- v) If candidate wishes to resign, candidate should give 01 month notice.
- vi) Selected candidate will be required to deposit a Security Deposit of One month payment in favor of Chief Executive Officer, MH-ESI Society, Mumbai at a time of Joining which is refundable after completion of contract period and production of "No Dues Certificate".
